**General Instructions: -**

1. You are aware that evaluation is the most important process in the actual and correct assessment of the candidates. 14. Any unassessed portion, non-carrying over of marks to the title page, or totalling error detected by the candidate shall damage the prestige of all the personnel engaged in the evaluation work as also of the Board.
