- 3. The Universal Copyright Convention (UCC)
  - i. National Treatment The UCC adheres to the principle of national treatment rather than automatic protection, which implies that contracting countries are not obligated to provide foreign works with automatic protection if the national requirements are not met.
  - ii. The term of the Work Under the UCC, original literary, artistic, and scientific works are eligible for protection. To provide reasonable notice of the copyright claim, a copyright notice should accompany the work. The UCC stipulates that protection for a work lasts for the duration of the author's lifetime and an additional 25 years following the author's death.
  - iii. Minimum Rights As per the UCC's provisions, the contracting countries must provide a specific set of "minimum rights" to the lawful owner of the work, provided they do not create any conflict with the "spirit" of the convention.

Given the absence of a written agreement between Ravi and Deepa, there should be an equal sharing of profits and losses unless there's proof of an agreement to the contrary. This default position is a protective measure but can lead to disputes when partners have different expectations.
