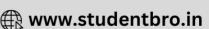
Another set of complications is created by the tension between the Indian state's simultaneous commitment to secularism as well as the protection of minorities. The protection of minorities requires that they be given special consideration in a context where the normal working of the political system places them at a disadvantage vis-a-vis the majority community. But providing such protection immediately invites the accusation of favouritism or **appeasement** of minorities. Opponents argue that secularism of this sort is only an excuse to favour the minorities in return for their

excuse for imposing the majority community's values and norms on the minorities.

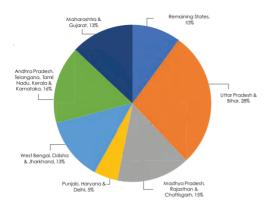

- a. Social movements aim to remove the social evils like the Sati system, prohibition of widow, remarriage, women illiteracy, child marriage, untouchability, social exclusion, etc.

- Individual inequality refers to destructiveness and variations among individuals in their psychological and physical characteristics. Social inequality refers to a social system where some people are getting the opportunity to make use of the resources and others are not. Some people are at a higher level in terms of wealth, education, health and status while others are st the lowest level.
- 21. Social movements seek to bring in social change, counter-movements sometimes arise in defence of the status quo. For example-formation of Dharma Sabha against Sati.
- 22. i. **Epidemic:** The term epidemic was derived from the Greek epi =upon; donors = the people i.e. upon the people refer to a sudden increase in the rate of which a disease affects the people of a given geographic area at a specific.
  - ii. **Pandemic:** The term pandemic refers to a state when an epidemic that is not restricted to a given geographical area but is more widespread i.e. national, international or global level.

- 24. i. Contract farming is a deal between farmers and companies. It is done by farmers who enter into a contract with companies that provide assistance to the farmer for growing the crop that they will purchase. Contract farming is very common now in the production of specialised items such as cut flowers, fruits such as grapes, figs and pomegranates, cotton, and oilseeds.
  - ii. The survey results show that the average revenue of a contract farm is **about 11 percent higher than an average non-contract farm**. The per hectare cost of production in a contract farm is about 13 percent lower and as a result the average profit margin under contract is more than 50 percent above those without contract.
- The colonial administrators were clear that harsh measures were taken against the labourers to make sure they benefited the planters.
  - They were also fully aware that the laws of a colonised country did not have to stick to the democratic norms that the British back home had to follow in Britain.
  - Since, the tea plantations were often located on uninhabited hill sides, bulk of the sorely needed labour had to be imported from other provinces.
  - Instead of giving them financial and other incentives, which the tea-planters of Assam were unwilling to offer, they took recourse to fraud and coercion.

## Section C

- 26. Post-independence, rural society in India underwent several key transformations:
  - i. Land Reforms: The abolition of zamindari systems aimed to redistribute land to the landless, reducing feudal exploitation.
  - ii. **Green Revolution**: Adoption of high-yielding varieties of seeds, fertilizers, and advanced irrigation techniques significantly increased agricultural productivity and ensured food security.
  - iii. **Cooperative Movement**: Formation of cooperatives empowered farmers by enhancing access to credit, resources, and markets, improving their economic stability.
  - iv. **Rural Development Programs**: Initiatives like the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) aimed to provide employment and improve infrastructure.
  - v. **Migration**: Economic opportunities led to increased migration to urban areas, transforming demographics and social structures in rural communities.

These changes collectively contributed to the modernization of rural India.

- 27. The impacts of caste in contemporary Indian Society are as below:
  - i. It has lost its rigidity, not totally disintegrated but maintaining its cultural significance.
  - ii. There is a changed structure as a result of industrialization, migration, urbanisation, technological advancement, etc.
  - iii. Legislations to abolish untouchability, birth-based privileges, exploitation.
  - iv. Social mobility is seen, open choice in occupation, education and standard of life.
  - v. No restriction on feeding and social intercourse in semi-urban and urban areas, marginally seen in rural areas.
- 28. The tribes were considered to be "People of the forest" whose special habitat in the hilly of and forest regions made their economic, social and political attributes. At present, except the North-Eastern states, there are no areas of the country which are





inhabited exclusively by tribal people.

The regions where the tribal population is concentrated, their economic and social conditions are much more than those of non-tribals.

However, after independence Adivasi lands were acquired for new river and dam projects. Consequently, millions of Adivasis were displayed without any adequate compensation or rehabilitation.

- i. In pre-independence time efforts made by Jyotibha Phule, Periyar, Ambedkar and others.
- ii. In contemporary times efforts made by political organisations like Bahujan Samaj Party in UP, Dalit Sangharsh Samiti of Karnataka.
- iii. Literacy contributions creating Dalit awareness especially in Marathi, Tamil Kannada Telugu and Hindi.
- 29. In India, the impact of the very same British industrialisation led to deindustrialisation in some sectors. And the decline of old urban centres. Just as manufacturing boomed in Britain, traditional exports of cotton and silk manufactures from India declined in the face of Manchester competition. This period also saw the further decline of cities such as Surat and Masulipatnam while Bombay and Madras grew. When the British took over Indian states, towns like Thanjavur, Dhaka and Murshidabad lost their courts and, therefore, some of their artisans and court gentry. From the end of the 19th century, with the installation of mechanised factory industries, some towns became much more heavily populated. Unlike Britain were due to industrialisation more people moved towards urban areas.

31. Communal politics refers to the use of religion in politics in which it is propagated that one's religion is superior to other religions. The political leaders try to misinterpret the basic ethics of the religion such as unity, brotherhood, communal harmony and omnipotence of God. Communal politics has only one base that community can be formed only on the basis of religion. It states that people of one religion are of the same community and their views, ideas, etc., are also the same. This communal politics also states that followers of different religions cannot make one community. In its ugliest sense, communal politics states that people of different religions are not equal and cannot live together in one particular area.

## 32. Different kind of work people do in society:

- i. In developed countries, the majority of people work in the service sector and less than 10% in agriculture or agriculture-related activities.
- ii. In India in 1999-2000, nearly 60% of people were employed in agriculture or mining, 17% in manufacturing, construction and utility sector, and 23% in the trade, transport and financial services sector.
- iii. However, in terms of contribution to economic growth, the share of these sectors has reduced and the services sector has become half. This is a cause for concern because the sector that employs the majority of people cannot generate much income for them.

## **Section D**

- 33. (1) **Population projections** are attempts to show how the human population statistics might change in the future. These projections are an important input to forecasts of the population's impact on this planet and humanity's future well-being. (2) The given chart represents regional shares of projected population growth up to 2041.
- 34. The three main dimensions of untouchability are:





- i. **Subordination and exploitation:** Untouchability is almost always associated with economic exploitation of various kinds, most commonly through the imposition of forced, unpaid underpaid labour or the confiscation of property.
- ii. **Exclusion:** Dalits experience forms of exclusion that are unique and not practised against other groups for instance, is prohibited from sharing drinking water sources or participating in collective religious worship, social ceremonies and feetivals
- iii. Untouchability may also involve forced inclusion in a subordinated role, such as being compelled to play the drums at a religious event.
- iv. **Humiliation and subordination:** The performance of publicly visible acts of self- humiliation and subordination is an important part of the practice of untouchability. Common instances include the imposition of gestures of deference such as taking off headgear, carrying footwear in the hand, standing with bowed head, not wearing clean or 'bright' clothes and so on as well as routinised abuse and humiliation.
- 35. The word Dalit is commonly used in Marathi, Hindi, Gujarati and many other Indian languages, meaning the poor and oppressed persons. It was first used in the new context in Marathi by neo-Buddhist activists, the followers of Babasaheb Ambedkar in the early 1970s. Different movements have highlighted different issues related to Dalits, around different ideologies. Notwithstanding differences in the nature of Dalit movements and the meaning of identity, there has been a common quest for equality, self-dignity and eradication of untouchability. (Shah 2001:194) This can be seen in the Satnami Movement of the Chamars in the Chattisgarh plains in eastern MP, Adi Dharma Movement in Punjab, the Mahar Movement in Maharashtra, the socio-political mobilisation among the Jatavas of Agra and the Anti Brahman Movement in south India. In the contemporary period the Dalit movement has unquestionably acquired a place in the public sphere that cannot be ignored. This has been accompanied by a growing body of Dalit literature.
