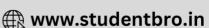

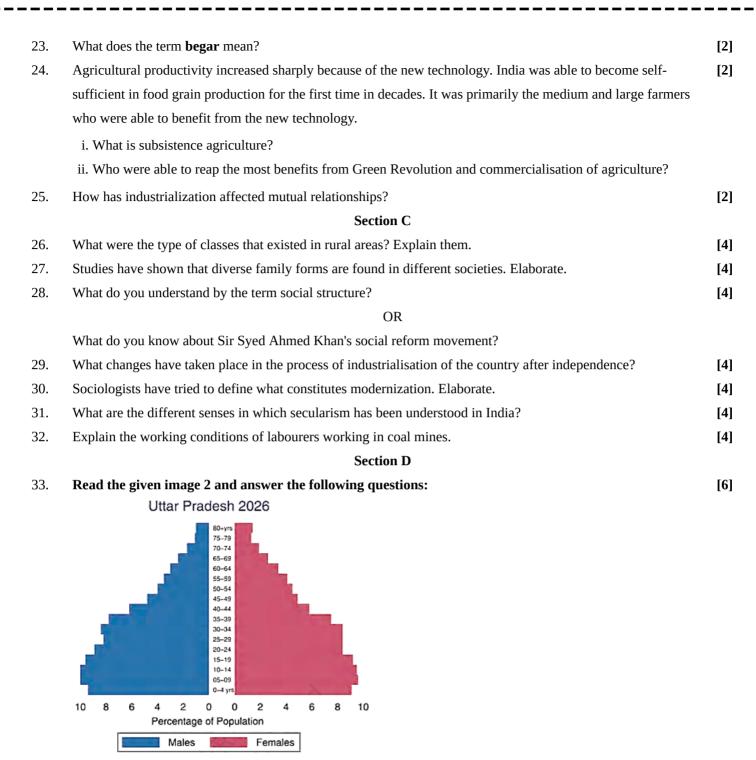

According to M.N. Srinivas Sanskritisation is the process by which members of a lower caste try to emulate the upper caste in terms of customs and traditions, ideologies and lifestyle. But in regions where Non-Sanskritised caste lower caste in the rural area became dominant and influenced the Sanskritised caste upper caste, this process is called De-Sanskritization.

Higher castes are expected to maintain strict hygiene and avoid contact with lower castes, which is believed to pollute their status. This leads to restrictions on social mobility and interactions, reinforcing caste boundaries.
- iii. **Occupational Roles**: Different castes traditionally have specific occupations, with those involving manual labor often viewed as polluting. This occupational division further entrenches ideas of purity and pollution.

Overall, these beliefs create a complex social hierarchy, where purity is maintained through practices and customs that often marginalize certain groups.

OR

Social exclusion refers to ways in which individuals may become cut off from full involvement in the wider society. It focuses attention on a broad range of factors that prevent individuals or groups from having opportunities open to the majority of the population.

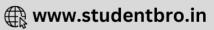

#### Section C

## 26. Some of the main classes that exist in rural areas are given below:

- i. **Land-owner farmers:** Steps were taken, after Independence, to change the existing systems related to land. The land was taken away from Zamindars by making laws and was distributed between the lakhs of landless farmers. Every landless farmer was given the land of one hectare free of cost. That is is how the landless farmers became land-owner. Before this, they used to do agriculture on the land of Zamindars. Now, they started practising agriculture on their own land.
- ii. **Gentleman Farmers:** Gentleman farmers were also a class of land owner-farmers. They did not have much of the land like zamindars. Those farmers were included in this group who either got land from their ancestors or have bought that land themselves.
- iii. **Middle caste and Middle-class farmers:** Powerful middle caste and middle-class farmers emerged in rural areas after Independence. They are known as middle caste because their position was lower than higher castes and higher than the lower castes in the caste hierarchy. Many landlords and big farmers of higher castes migrated towards urban areas to take advantage of industrialisation and urbanisation. They started to invest their money in industries. Under these circumstances, middle caste and middle-class farmers emerged in rural areas.
- 27. Family forms and structures vary significantly across different societies due to the influence of cultural, social, economic, and legal factors. Diverse family forms exist across societies due to various factors. These include cultural norms, economic





conditions, and legal frameworks. For instance, nuclear families are common in Western societies, while joint families are prevalent in many Asian cultures. Additionally, single-parent families, same-sex parent households, and childless couples represent other diverse family structures. These variations highlight the adaptability and complexity of family relationships in different social contexts.

- 28. i. The term 'social structure' is concerned with the structure of the family which can be studied in two ways:
  - a. As a social institution, and
  - b. In its relationship with other social institutions.
  - ii. As a social institution, it can be either a nuclear family or an extended family. Family can be male-dominated or female-dominated. It can be patrilineal or matrilineal. Generally, the internal structure of a family is like other structures such as political, economic and cultural structures.

OR

Sir Syed Ahmed Khan's efforts aimed at reforming the Muslim society. He wanted girls to be educated, but within the precincts of their homes. Like Dayanand Saraswati of Arya Samaj, he stood for women's education but sought for a curriculum that included instruction in religious principles, training in the arts of housekeeping and handicrafts and rearing of children. This may appear very stereotypical today but one has to realize that once such rights were such as education for women were accepted. It started a process that finally made it impossible to confine women to only some kind of education.

- 29. Changes have taken place in the process of industrialisation of the country after independence are:
  - i. Few industries were established in India before independence because it was not possible to get proper facilities from a foreign government.
  - ii. Before 1947, only two steel producing units were present in India, but they increased very quickly after independence.
  - iii. The government made five-year plans whose main objective was the industrial development of the country.
  - iv. After 1947, this process assumed a great speed. India made very good progress in the field of the iron industry, trackers, cars, scooters, motorcycles, electronics, fertilizers, chemicals, heavy industries, etc.
  - v. India is now one of the leading producers of clothes in the world. It also made great progress in the fields of coal, shipping, petroleum products, etc.
  - vi. Foreign investment in the country increased quickly after 1991 and India is now emerging as an industrialised country.
- 30. The term modernisation has a long history. From the 19th and more so the 20th century the term began to be associated with positive and desirable values. In the early years, modernisation referred to improvement in technology and production processes. It referred to the path of development that much of West Europe or North America has taken. Modernization assumes that local ties and parochial perspectives give way to universal commitments and cosmopolitan attitudes. People are influenced not just by local but universal contexts. Work gets based on choice, not birth. A scientific attitude and a rational approach matters.
- 31. Right from the beginning of 20th century, Indian society is constantly changing from a sacred society to a secular one. Many scholars of this century observed that India could remain united on the basis of secularism because people of many religions live over here. On the basis of secularism, all the religious groups and religious beliefs of a state are considered as equal. The meaning of secularism is to remain away from all the religions and not to give preference to any particular religion. All the religions are equal before the state and no religion is discriminated on this base. Secularism is that concept or policy in which people are not being forced to obey any particular religion.
- 32. The working conditions of laborers in coal mines are often challenging and hazardous. Key aspects include:
  - i. **Hazardous Environment**: Coal mines are prone to various risks, including explosions, cave-ins, and exposure to harmful dust and gases like methane and carbon monoxide, leading to serious health issues.
  - ii. **Long Working Hours**: Miners typically work long shifts, often exceeding eight hours a day, which can lead to physical exhaustion and health problems over time.
  - iii. **Physical Strain**: The work involves heavy lifting, manual labor, and working in cramped, uncomfortable spaces, contributing to musculoskeletal injuries.
  - iv. **Lack of Safety Measures**: Despite regulations, many mines may lack adequate safety equipment and training, increasing the risk of accidents.
  - v. **Poor Health and Safety Standards**: Health issues, including respiratory diseases like pneumoconiosis (black lung disease), are common due to prolonged exposure to coal dust.
  - vi. **Inadequate Compensation**: Laborers often receive low wages compared to the risks they face, leading to economic instability for their families.

Overall, coal mining remains one of the most dangerous occupations, with ongoing efforts needed to improve safety and working conditions.





#### **Section D**

- 33. (1) It is because older people make up a relatively small proportion of the population.
  - (2) Economic activity grows in younger populations due to the influx of new people causing population growth. A bias towards younger age groups in India's age structure can positively impact economic activity. With a large, youthful population entering the workforce, there is potential for increased productivity and economic growth. This "demographic dividend" provides an opportunity for innovation, entrepreneurship, and a growing consumer base. However, to fully harness this potential, India must invest in education, skill development, and job creation. Otherwise, a mismatch between available jobs and workforce skills could lead to unemployment and social challenges.
- 34. i. The OBCs are a much more diverse group than the Dalits or Adivasis. Jawaharlal Nehru as Prime Minister appointed a commission to look into measures for the welfare of OBCs. The first Backward Classes Commission headed by Kaka Kalekar submitted its report in 1953, but it was being sidelined.
  - ii. From the mid-fifties, OBCs became a regional affair pursued by the state rather than the centre. In the early 20th century the southern states started political agitations. Because of these powerful social movements, policies to address the problems of OBCs were in place long before they were discussed in northern states.
  - iii. The politicisation of the OBCs allows them to convert their large numbers recent surveys show that they are about 41% of the national population- into political influence. This was not possible at the national level before, as shown by the sidelining of the Kalelkar Commission report, and the neglect of the Mandal Commission report.
  - iv. The large disparities between the upper OBCs and the lower OBCs make this a difficult political category to work with. However, the OBCs are severely under-represented in all spheres except landholding and political representation.
- 35. The tribal movement that resulted in the formation of a separate state of Jharkhand: Jharkhand is one of the newly-formed states of India, carved out of south Bihar in the year 2000. Behind the formation of this state lies more than a century of resistance. The social movement of Jharkhand had a charismatic leader Birsa Munda, an Adivasi who led a major uprising against the British. Birsa became the important icon of the movement. Stories and songs about him can be found all over Jharkhand. The memory of Birsa's struggle was also kept alive by writing. Within South Bihar, Adivasis shared a common hatred of dikus migrant traders and moneylenders who had settled in the area and grabbed its wealth, impoverishing the original residents. Most of the benefits from the mining and industrial projects in this mineral-rich region had gone to dikus even as Adivasi lands had been alienated. Adivasi experiences of marginalization and their sense of injustice were mobilized to create a shared Jharkhandi identity and inspire collective action that eventually led to the formation of a separate state.

The issues against which the leaders of the movement in Jharkand agitated were:

- a. Acquisition of land for large irrigation projects and firing ranges.
- b. Survey and settlement operations, which were held up, camps closed down, etc.
- c. Nationalization of forest produces which they boycotted.
- d. Collection of loans, rent and cooperative dues, which were resisted.
